ENTRY FEE: Payable to Hudson Society of Artists (HAS) \$30.00 for up to 2 pieces - cash or check

ELIGIBILITY: Open to all CURRENTLY PAID members of Hudson Society of Artists. ORIGINAL WORK ONLY. Work must be the artist’s own creation/concept. Limit TWO (2) pieces. Entries may include three-dimension and two-dimensional work in any medium framed or unframed wrap-around canvases; side stapled canvases must be framed. Works on paper must be framed and under glass or Plexiglas. Secure with wire and D-rings for hanging. No saw-tooth hangers. Mats must be clean. Frames are to be in good condition with no scratches, dents or open corners. A diptych must be framed as one piece. Largest size to be no larger than 36” x36” and **under 25 pounds.** 2-D work must fit through doorways. **No giclees, reproductions or NFS will be accepted.**
WE RESERVE THE RIGHT TO DETERMINE THE ACCEPTABILITY OF ANY ENTRY.

SALE OF ITEM: There will be a **30% commission** on the sale of any and all artwork. Prices from previous shows should be consistent. All artwork **must be for sale. NO NFS will be accepted.**

DROP-OFF/PICKUP: See schedule above. If the drop-off and/or pickup times are not convenient, please make arrangements for someone to transport your art work.

ALL PIECES MUST HANG FOR THE DURATION OF THE SHOW AND CAN BE PICKED UP ON Friday, May 3 and Saturday, May 4 between the hours of 11:00 - 3:00.
